

Dear FTC,

In compliance with the order dated December 13, 2002 the following is my written report setting forth how I have complied with the order.

Section I: I have not since the order of December 13, 2002 and will not make any representation regarding SNORENZ in any manner. I have not been involved in any manner with SNORENZ since the order of December 13, 2002. I will not to be involved with any advertising, manufacturing, labeling, promotion, sale, distribution of any product involved in reducing or eliminating snoring.

Section II: I have not since the order of December 13, 2002 been involved and will not represent that any product is effective in reducing or eliminating snoring. I have not and will not be involved ( in any fashion) in any television commercials, video advertisements, broadcasting, or cablecasting regarding any snoring product.

Section III: I have not since the order of December 13, 2002 been involved and will not be involved with the endorsing, manufacturing , labeling, advertising, promotion, offering for sale, sale, or distribution of SNORENZ or any other product. I will reject any participation in the endorsement of any product.

Section IV: I have not since the order of December 13, 2002 been involved and will not be involved in endorsing any product, service, or program, or in expressing the existence of any test , study, or research for any product.

Section V: I have not since the order of December 13, 2002 been involved and will not be involved with the endorsing any product, service, or program that I have a material connection.

Section VI: Although this section allows me to make a representation regarding a drug that is permitted in labeling by the Food and Drug Administration. I have not and will not be involved in making any representation regarding any drug.

Section VII: Although this section allows me to make representation for a product permitted by the Food and Drug Administration I have not and will not make any representations.

Section VIII: I have not had in my possession any advertisements or promotional materials, tests, reports, studies, or any evidence. All materials regarding Med Gen , Snorenz were maintained by Med Gen company. I will not be involved in any advertisements, promotions, tests, reports, studies, surveys, or demonstrations.

Section IX: I have not changed my employment or my employment address. I have included the Federal Trade Commission with the list of people to advise of any change of address if it should happen in the future.

Section X: I have complied with the order of the Federal Trade Commission Order as I have not been involved in the product SNORENZ since the order and do not plan to be involved with the product. I have filed this report within the time requirement.
